Q&A

Q: What is the difference between a license for spiritual healers and an ordination?

A: Soft tissue manipulation, energy, touch and other words are being added to state licensing boards for health care in several states: a trend that creates exclusivity. These words, and any modalities that use them, then become the exclusive province for health care licensing such as massage, nursing and medical personnel. Clergy, however, have an exemption clause in Medical Practices Acts in every State in the U. S.

Q: Will any ordination cover us?

A: The brief answer is yes, maybe. The detailed answer is emphatically YES if the religious organization issues a *Letter of Direction* to engage in holistic methods as part of, and the exclusive purpose of, your practice.

Lightwing Center offers a *specific Directive for Raindrop Technique®*, *Young Living aromatherapy*, any other holistic modalities and practices you may use. The Letter of Direction is given after all requirements are met. It is in the form of a Notarized Contract, and adherence to the Directive is a condition for your Ordination as a Practitioner to remain recognized.

Q: Where can I attend an Ordination Class??

A: At present there are instructors based in NJ and NY. Until the pandemic is controlled travel is discouraged. A schedule of events is posted at lightwingcenter.org and the YL site in Events.

Q: If I live in another state, instead of traveling to a class, can it be held in my state?

Q: What is the fee?

A: The fee is \$275.
